Our farm has been the sole organic grower at the Montclair Farmers Market for the past 14 years and we have a well established reputation for quality and value. During the 2015 season the farm served over 700 families in the CSA program.

Circle Brook Farm is an 80 acre farm in Andover NJ, just 35 miles from Caldwell.

Our mission is to produce a wide variety of clean, tasty, nutrient dense fruits and vegetables in an ecological and sustainable manner.

We grow a wide variety of produce including many heirloom and unusual varieties, such as Hakurei salad turnips, ground cherries (aka Cape gooseberries) and varieties of lettuce and beans that you will never find in the supermarket.

We grow over 100 varieties of tomatoes and 20 types of potatoes.

All selected for superior eating quality and not solely for high yields. We amend our soils with rock dusts and natural fertilizers to insure our veggies offer the best possible nutrition for you and your family.



We offer 24 weekly shares beginning in early June and ending in late November.

Early season shares typically contain 7-8 items while main season distributions may feature up to 12.

Almost every weekly share will contain:

lettuce

greens (spinach, arugula, kale, Swiss chard etc.)

root vegetables (carrots, beets, radishes, turnips, parsnips etc.)

brassica family vegetables (broccoli, cabbage, cauliflower etc.)

alliums (onion, garlic, leek etc.)

herbs (basil, cilantro, dill, parsley etc.)

Also included through the course of the season will be: **peas** (English, sugarsnap, snow), **beans, zucchini, cucumbers, tomatoes, peppers, eggplant, escarole, radicchio, celery, melons and watermelon, sweet potatoes and winter squash** and more.

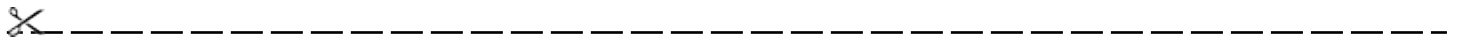

I commit to membership in the Circle Brook Farm CSA for the 2017 season which is planned to run for 24 weeks. As a member of the CSA, I will receive a weekly share of produce. The shares will vary by size and weight depending on the time of the season.

One aspect of CSA is that members support their farmer by sharing in the inherent risks of agriculture (poor weather, drought, disease, early frost, crop failure and so on) and rewards (the bounty from a good season.) CSA farmers purposely plan for such contingencies, and use growing techniques that protect the harvest, minimizing risk to members and optimizing the rewards. By growing a wide variety of crops that thrive in different types of conditions, cover cropping, crop rotation, and irrigation, Circle Brook Farm does its best to ensure a plentiful season. Moreover, the CSA builds relationships of trust between the farmer and community group. During peak growing season, members should get a wide variety of vegetables in plentiful amounts. By signing below I agree that while Circle Brook Farm will act in good faith to provide fresh organic produce for the duration of the season, there is no guarantee of quantities or contents of weekly shares.

I am fully aware that it is necessary to inspect and wash all produce thoroughly before consuming. I understand that Circle Brook Farm and Dough Artisan Pizzeria are separate entities, and assume no liability for the food safety of CSA shares.
